

Minutes from the Supreme Court | November 14th, 2023

Regular Meeting

The Supreme Court of the Student Government Association of Tennessee Tech met at 11:14am on November 14th, 2023, in the Center for Student Engagement Conference room. Chief Justice Bryson Lee was present and presiding. The meeting was recorded. Chief Justice Lee took the roll, and a quorum was established. As the previous meeting's minutes had been provided in advance to all members, Chief Justice Lee considered them read without objection. The previous meeting's minutes stand approved. Justice Gracy **MOVED** that all three cases be merged into one case with only one majority opinion to be written for all three submitted cases. Seconded. The motion was **ADOPTED** with **7 AYES** and **0 NAYS** with Justice Williams not being present for the vote.

Chief Justice Lee sought **UNANIMOUS CONSENT** to fix the time to adjourn at 11:50am. The motion was **ADOPTED WITHOUT OBJECTION**.

The Supreme Court entered a period of informal consideration on the pending cases.

In accordance with the adopted motion to fix the time to adjourn, Chief Justice Lee declared the Supreme Court **ADJOURNED** until the special meeting on November 16th, 2023, at 6:00pm without objection at 11:50am.
