## Approval of Revised Policy 221 Substantive Change Second Reading

## Approval of Revised Policy 261 Academic Credit from Other Institutions Second Reading

Professor Winkle noted the revised Policy 261 Academic Credit from Other Institutions was submitted as a second reading and, therefore, the policy will be available for an actionable vote. Dr. Sharon Huo presented and stated that no changes or suggestions were given at the first reading. Dr. Darron Smith MOVED approval and Dr. Christy Killman SECONDED. APPROVED unanimously.

#### **Recommended Changes for the Outstanding Faculty Awards Committee**

Dr. Bedelia Russell stated that Dr. Curtis Armstrong and herself took all of the discussion and suggestions by the committee members over the past year's meetings, to draft the revisions to the Outstanding Faculty Awards Policy with the focus being to craft a policy that allows for award expansion, including an award for first year/early career faculty and adjunct faculty. If revisions are approved, it would allow for the next cycle of award notifications to expand under the new policy revisions. Dr. Brian O'Connor and Dr. Scott Christen made suggestions such as determining the number of awards that would be given in each category before the call for nominations, and adding a statement of intent, indicating the various categories should be included near the start of the policy in order to set the context of the policy. After much discussion, the agenda item was tabled and will be reintroduced at a future meeting. No vote.

#### Department of Mechanical Engineering ENAPP Proposal – Nuclear Engineering

Dr. Rao stated the BS in Nuclear Engineering program has undergone comprehensive planning and review, including input from faculty, experts in the field, and external stakeholders. It aligns with our institution's mission and strategic goals, and we believe it will provide valuable opportunities for students and contribute to the academic offerings of our university. Dr. Darron Smith MOVED approval and Dr. Christy Killman SECONDED. APPROVED unanimously.

#### College of Engineering Proposal for PhD in Computer Science

Dr. Jerry Gannod stated for the establishment of a Ph.D. in Computer Science from a Ph.D. in Engineering is driven by three factors: the recruitment of computer science graduate students into our program, the ability or our graduates to get jobs, and the recruitment of new faculty. Dr. Darron Smith MOVED approval and Dr. Christy Killman SECONDED. APPROVED unanimously.

# College of Interdisciplinary Studies School of Environmental Studies Graduate Admission Policy Change

Dr. Hayden Mattingly stated the School of Environmental Studies request approval to change the admissions policy by removing the requirement for the GRE. Recent studies have shown that there is little correlation between GRE scores and success in graduate schools and that the GRE requirement puts underrepresented groups at a disadvantage. Dr. Darron Smith MOVED approval and Dr. Christy Killman SECONDED. APPROVED unanimously.

# College of Arts and Sciences Adding a PC Course Option for the Professional and Technical Communication Concentration

Dr. Linda Null stated this change would allow students to add a PC course to their program of study for flexibility in meeting academic and career goals. Dr. Darron Smith MOVED approval and Dr. Christy Killman SECONDED. APPROVED unanimously.
