Programming and Publicity Subcommittee Report November 10, 2020

The subcommittee met on October 29, 2020 to discuss potential speakers to propose to Center Stage for 2021-22. We chose three possibilities (Maya Dusenbery, Tamara Winfrey-Harris, and Andi Zeisler) to contact to find out if their speakers' fees are in the range of the typical Center Stage Budget. All three quoted a reasonable range (\$7,500 plus travel or less). I sent out a survey for the subcommittee to rank each of the three speakers. Everyone who voted selected Maya Dusenbery as their first choice and four selected Tamara Winfrey-Harris as their second choice.

The subcommittee requests that the full CSW votes to agree that we submit a proposal to Center Stage to have Maya Dusenbery as a speaker in March of 2022. In case we cannot negotiate a reasonable speaker's fee for Dusenbery, we propose Tamara Winfrey-Harris as a backup plan.

The CSW Awards dinner will be held tomorrow (Wednesday, November 11) evening at 5 p.m. in the Multipurpose Room of the RUC. The inaugural CSW Excellence Award will be presented to Yvette Clark from ITS and the Alison Piepmeier Outstanding Student Award will be presented to Amy Bosley.

The subcommittee is now accepting nominations for both awards for 2021. The call for nominations has been posted to Tech Times and the Project Awaken (@ntechawaken) Instagram. It should be posted to the Women's Center Facebook and Instagram soon.

I would like to request permission to work on updating the CSW webpage to include information about our awards similar to the pages for the Scholar-Mentor and Caplenor Awards. I don't have access to change the webpage, but am happy to do so, if someone can give me a login. The subcommittee will present a draft to the full committee for approval before making any changes.

I mentioned at our last meeting that I wanted to see if the committee had any interest in pursuing a virtual speaker who is a friend of a friend. I have not been able to speak with her yet, but she is interested in the possibility. The speaker would be Officer Jules Sohn of the Los Angeles Police Department. Twitter bio: Marine veteran, public servant, LGBTQ Cultural Competency instructor, defender of Equality & 1st Amendment. Since we don't meet in December, when would we suggest the event be held (if it is possible)?
