Discussion of Expedited Reviews Since the Last Meeting

Floor was opened for discussion. It was noted that the Betsy Moon application does not have a status. Dr. Seiler advised it was approved 9/6/22.

Discussion of Vice Chair/Temporary Chair for Spring 2023

Dr. Seiler advised that his availability will be reduced in the Spring and to avoid any potential delays for applications he suggested a Vice Chair or temporary chair be appointed by the committee who will have the authority to process expedited applications. Michael Clark volunteered to fill that role. No objections were heard.

Review of Exempt, Expedited, & Full Board Requirements and Expedited Review Process

- Exempt requires only Department Reviewer
- Expedited requires a board sub committee of three members to review
- Full Board requires the entire IRB Board to review
 - When in doubt, push to next level, more reviewers is better
 - IRB is there to protect the University and the PI

- Consider the three Basic Principles of the Belmont Report; Respect of persons, beneficence and justice
- Reviewer can ask for references to show base line knowledge and a scientific agenda
- Committee can invite expert to meeting for feedback
- Only way to reject is by full-board

Such Other Matters

Queen Ogbomo asked if IRB is required element of grant should it be obtained at the time of the proposal or after award is received. Dr. Seiler recommended doing that at the proposal stage.

Dr. Pinkert inquired if any other training is required for IRB members besides the CITI training. Dr. Seiler advised that there is not. Dr. Pinkert advised that there is available training through the OHRP site, Primer Plus and FDA. Some of the training is specific to IRB Chairs and IRB leadership. Other institutions mandate the training for chairs but make it available to all IRB members. Dr. Seiler will send a survey to the committee members.
