**Mission/Vision:** The mission of the TN eCampus Master of Science in Nursing program is to use technology to improve access to high-quality, affordable, student centered graduate nursing education opportunities through cooperation with other universities. The vision of the TN eCampus Master of Science in Nursing program is a better life for Tennesseans through excellence in graduate nursing education. The program offers concentrations in Nursing Education, Nursing Administration, Nursing Informatics, and Family Nurse Practitioner (having the highest enrollment). Additionally, the program offers post-master's certificates (PMC) in the four aforementioned concentrations.

The purposes of the TN eCampus Master of Science in Nursing program are to:

- Increase access to graduate nursing education, especially for nurses aspiring to teach in entry-level nursing programs, manage professional practice work settings, and practice as advanced clinicians in a changing healthcare delivery system.
- Maximize the effective use of technology for delivery of graduate-level instruction. Distance delivery through the use of technology will increase access to graduate education, especially in remote areas of the state and for practicing nurses for whom time flexibility is a critical resource.
- Provide student access to web-based courses and degree programs. Web-based courses will reach populations not currently enrolled in graduate education, and will also permit students who are currently enrolled in on-campus courses to take additional courses, thus completing the program sooner.
- Encourage and support collaboration among TN eCampus institutions. Course development and delivery will be cost-effective because courses will be developed by one institution and used by all.

**Program Goals:**

1. The Whitson-Hester School of Nursing will maintain compliance with required agencies.
  - a. The Whitson-Hester School of Nursing will demonstrate ongoing accreditation through the Accreditation Commission for Education in Nursing (ACEN).
  - b. The Whitson-Hester School of Nursing will demonstrate ongoing full approval of the Tennessee State Board of Nursing.
2. Graduates of the Whitson-Hester School of Nursing MSN will pass certification.
3. MSN students will graduate the program in a timely manner.

4. Provide students with a strong group of academic faculty.

**Student Learning Outcomes:**

1. MSN students will synthesize nursing knowledge into evidence-based practice.
2. Practice advanced nursing roles in collaborative relationships across disciplines, managing health care within legal, ethical, and professional standards.
3. Promote positive changes in safe health care delivery, health policies, and nursing practice through quality improvement and safety standards.
4. Concentration specific outcomes
  - a. FNP - Demonstrate competency in providing primary care across the life span to individuals, families, groups, and communities.
  - b. Nursing Administration - Demonstrate advanced level nursing administration competencies in healthcare delivery systems, policies, and practice.
  - c. Nursing Education - Demonstrate nurse educator competencies in didactic and clinical settings, with a working knowledge of organizational structure and role responsibility.

A departmentally developed curriculum map can be found in Appendix 1 that shows the connections between courses and student learning outcomes.

**Assessment Methods:**

1. *ACEN Accreditation and the TN State Board of Nursing:* Self-study and on-site evaluations by ACEN provide an opportunity to examine closely all aspects of the academic program, including program quality relative to: 1) Mission and administrative Capacity; 2) Faculty and staff; 3) Student policies, development, and services; 4) Curriculum; 5) Resources; and 6) Student learning. Nationwide certification examination pass rates, evaluation of outcomes for congruence with similar on-ground programs, and percentages of students who obtain jobs serve to evaluate quality.
2. *ANCC and AANP National Certifications:* The Family Nurse Practitioner (FNP) certification examination is an entry-level competency-based examination that tests clinical knowledge in family/individual across the life span (prenatal, pediatric, adolescent, adult, older adult, and elderly primary care). 90% of graduates should pass on their first attempt.
3. *TN eCampus Graduation and Retention Rates:* Graduation rates defined by TN eCampus are 150% of the prescribed program length. Six years for FNP; Five and one/half for other concentrations.
4. *TN eCampus Aggregate Faculty Outcomes:* Aggregate Faculty Outcomes Consistent with and Contributed to the Achievement of programs, Mission, Goals and Expected Outcomes. In 2018 the WHSON revised the faculty outcomes to be more objectively measured.
  - 90% of tenured/tenure track faculty hold a terminal degree.
  - 100% of adjunct faculty members hold a master's degree in nursing or higher.

- 75% of tenured/tenure track faculty demonstrate at least two scholarly contributions from the following areas each year: manuscript or chapter submission; peer-reviewed publication; application for external/internal funding; achievement of external/internal funding; active IRB; state, national, or international presentation; review for professional journal; review for grant proposal.
- 100% of full-time faculty maintain college/university/community service contributions consistent with designated rank.
- 100% of full-time faculty who require national certification for teaching advanced practice nursing maintain certification in their specialty
- 100% of full-time faculty engage in at least one professional development activity each year, such as: workshop or conference attendance, earning CEUs, enroll in educational program of study, earn new or additional certification
- To demonstrate teaching effectiveness, the aggregate score on the Summary of Teaching Effectiveness from the Student IDEAS Evaluations will be at least 3.0 in these areas:
  - Summary Evaluation
  - Progress on Relevant Objectives
  - Overall Rating

**Results:**

*Program Goal 1: The Whitson-Hester School of Nursing will maintain compliance with required agencies.*

- a. The Whitson-Hester School of Nursing will demonstrate ongoing accreditation through the Accreditation Commission for Education in Nursing (ACEN).*
- b. The Whitson-Hester School of Nursing will demonstrate ongoing full approval of the Tennessee State Board of Nursing.*

Tennessee Tech University's Whitson-Hester School of Nursing (TTU WHSON) is a current partner in the TN eCampus Master of Science Nursing program along with the Schools or Colleges of Nursing at Austin Peay State University, Tennessee State University, and the University of Memphis. In the Fall 2017, Middle Tennessee State University and East Tennessee State University, two members of the original consortium, left the consortium and are currently seeking accreditation as independent MSN programs at their respective universities. All course work is online, with the exception of the clinical practicum experiences. This program offers the following concentrations: Family Nurse Practitioner (FNP), Nursing Education, and Nursing Administration and is accredited by ACEN. In light of the potential effects with

these schools leaving the TN eCampus MSN program, TTU WHSON will “teach-out’ students in the TN eCampus and the school has an independent TTU Whitson-Hester School of Nursing MSN program.

TTU MSN program started Fall 2018 and offers the following concentrations: Family Nurse Practitioner (FNP), Nursing Education, and Nursing Administration. The TTU WHSON MSN program adheres to the curriculum and online course delivery of the current TN eCampus MSN program but all courses are taught solely by TTU faculty to exclusively TTU MSN students. TTU MSN program is seeking CCNE initial accreditation in September 2019.

*Program Goal 2: Graduates of the Whitson-Hester School of Nursing MSN will pass certification.*

In 2018, the TN eCampus (TTU Whitson-Hester School of Nursing-Home Students) FNP combined certification pass rate for first-time exam takers matched the AANP National first-time pass rate at 85%. The TTU ANCC Pass Rate fell just below at 85% of the national pass rate at 86%.

*Program Goal 3: MSN students will graduate the program in a timely manner.*

Determining the 2018 graduation rate based on the TN eCampus definition resulted in a graduation rate of 79% based on students admitted in the calendar year 2012 having six years to complete the program.

63 students admitted in 2012 (Spring, Summer & Fall).

50 students graduated within 150% of the projected program length.

10 students withdrew from program on good standing.

3 students were not successful.

**Modification for Improvement:**

*Program Goals 2: Graduates of the Whitson-Hester School of Nursing MSN will pass certification.*

Lower than expected certification rates led to curricular changes when the TNTech program was implemented.

As the WHSON at TTU transitioned from TNeCampus MSN to the TTU MSN, the WHSON began the process of addressing the certification rates for the FNP concentration with a review of the curriculum and introduction of curricular changes to the FNP concentration. These changes more closely mirrored the National Task Force Guidelines for Family Nurse Practitioners with an increased focus on primary care rather than specialization in any particular field. The proposed plan included an FNP I and II didactic and clinical practicum, and combined the Women’s Health and Pediatrics content into FNP III with a primary care focus. The Scholarly Synthesis course was dropped from the FNP concentration and a Role Transition to Certification and Practice was added with an emphasis on clinical reasoning and standardized testing. This proposal was approved by the TTU Graduate Studies Executive Committee

March, 2019 and became effective Fall 2019. The first FNP graduates from this program are slated for Fall 2020.
