CITI Training for Departmental Reviewers

This training is required of all Departmental Reviewers.

Departmental Reviewers are appointed by their department chairpersons or, as appropriate, college dean. In order to be certified once appointed, the following training must be completed.

The training should take a few hours to complete; however, it does not need to be completed in one sitting. It consists of 17 brief modules, each with a two- to five-question quiz. All quizzes must be passed with an 80% or better.

Create an account through the "Register" link.

Step One:

- → Under "Select Your Organizational Affiliation," select "Tennessee Technological University."
- → Check "I AGREE to terms..."
 - → Continue to Step #2

Step Two:

- → Provide name and TTU email address.
 - → Continue to Step #3

Step Three:

- → Select a username & password
 - → Continue to Step #4

Step Four:

- → Select country of residence
 - → Continue to Step #5

Step Five:

- → Select "No" and "No"
 - → Continue to Step #6

Step Six:

- → Provide required information
- → Under "Role in Research," select "Principal Investigator."
 - → Continue to Step #7

Step #7:

- → Under "Question #1," select "Departmental Reviewer."
- → Under "Question #2," select the Responsible Conduct of Research for your related field.
- → Under "Question #3," select "Not at this time."
- → Skip "Question #4."
 - → Continue to Step #8
 - → Finalize Registration
 - → You're now ready to complete the "Departmental Reviewer" training.
