Fall 2025 Session

Regular Meeting on August 25th, 2025

The Senate of the Student Government Association of Tennessee Technological University met on August 25th, 2025, at 7:00 PM in the RUC Multipurpose Room. Speaker of the Senate Maya Seitz was present and presiding. Secretary Autumn Cecil was present and taking minutes.

Speaker Seitz led the Senate in reciting the Pledge of Allegiance and observing a moment of silence. The roll was then called, and a quorum was established.

The minutes from the previous meeting were then declared read and approved.

The agenda attached as Appendix A was then adopted as the orders of the day.

Tennessee Secretary of State Tre Hargett presented to the Senate the impact of voter registration drives and the importance of being an active voter.

Speaker Seitz opened the floor to public comment. Harrison Simpson and Aaron Cofer addressed the Senate on their organization, Indivisible Upper Cumberland. Seeing no other members of the public wishing to comment, the floor was closed.

Sen. Gillis delivered a summary of the S.O.L.O. Funding Committee report.

Sen. Gillis delivered their report on the activities of the Stormwater Management Committee and Secretary Heineman delivered their report on the activities of Sustainable Campus Committee.

Chief of Staff Mcculley gave the reports of the Advisor of Executive Programs on behalf of Advisor Moore and the Secretary of Communications and Outreach on behalf of Secretary Boynton. Chief of Staff Mcculley, Secretary Apple, Secretary Owens, and Secretary Heineman then proceeded to deliver their respective reports.

President Bare delivered the report of the Treasurer on behalf of Treasurer Guadalupe, then Secretary Cecil, Vice President Seitz, and President Bare delivered their respective reports.

All reports were received and placed on file by Secretary Cecil.

The Senate proceeded to the presentation of the SY 2025-2026 SGA Budget, presented by President Bare on behalf of Treasurer Guadalupe. After debate, the budget for the 2025-2026 school year passed with a vote of 18 members voting aye, 0 members voting no, and 0 members abstaining via roll call vote.

Speaker Seitz opened the floor for announcements. Sen. Stevens, Attorney General Tidwell, Sen. Casebier, and Sen. Gibbs all made announcements.

In accordance with the orders of the day, Speaker Seitz declared the meeting adjourned without objection at 8:10 PM until Monday, September 15th, 2025.
